

# 2016 CA Water Board Data Fair

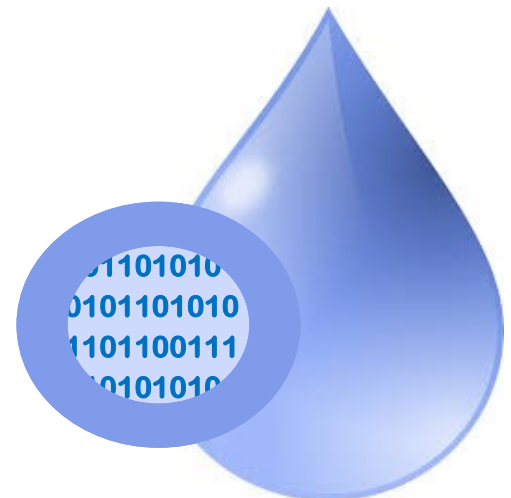
